#### **Unfinished Business**

## Affiliation Committee Review / Output (Karen, Duncan, and Hugh)

- USSSA not chasing our business; focused on wide-range of adult and youth sports; not just soccer
  - Comparison chart provided by Affiliation Committee
  - Very limited opportunities exist related to USSSA
  - Eliminate option around USSSA
- USASA or going direct affiliation with US Soccer
  - Insurance and liability coverage
  - Flat \$10 fee going back to USASA; \$5 fee recreational
  - Invitation from ISSA to Bruce around our proposal
  - Action items: obtain information around insurance fees outside of USASA (Duncan, Karen and Gaetano)
  - Affiliation Committee will act on behalf of board members to present proposal to USASA
  - Plan of action to compare USASA and US Soccer direct affiliation
